Dismiss rider/horse at time deemed unsafe, abusive or illness/lameness.

**The Judges decision is final. No speaking to the Judge till end of show.**

**High Point Award: This is a One Equine/One Handler Award.**

**You must show at all three shows to qualify for a High Point Award.**
